Entries must consist of graphic material and text adequate to explain the project. All entries must be submitted on a CD-ROM labeled with the project name and location only. The CD-ROM should be submitted in a clear jewel case also identified with the project name and location only. All CD-ROMs will be retained by DXR'09 as part of the program archives. A check payable to Design Expo Raleigh for the submittal fee must accompany each application. The fee for Student submittals is \$15/entry. The fee for Professional submittals is \$50/entry.

Biographic Information (Include on CD)

- 1) B&W photo of the main designer or designers or firm logo (3"x3" at 300 dpi) JPEG format.
- 2) Firm Profile - no more than 150 words in Microsoft Word.

Project Graphics (Include on CD)

- 1) Publicity Image - (8"x8" at 300 dpi) JPEG format without firm name or logo
- 2) Final displays will consist of two (2) 16"x16" boards representing your work (see attached "Exhibition Boards – Requirements" for details). We suggest you format and submit these boards for your submittal. However, any format of individual images or views will be accepted for jury review at this time. No entry is to exceed 12 total views. Each image or view must be suitable for digital display [JPEG, GIF, PNG and maximum resolution of 72 dpi at 800x800 pixels]. No firm name shall be placed on any view or image in this submittal. To insure project anonymity the Awards Jury will only have access to these images and/or views. Those entries selected for display at DXR'09 will be required to be placed in our final display format by the entrant. The firm name will be allowed on the final display boards of the selected designs.

Project Information (Include on CD)

- 1) Project Statement Form – no more than 250 words on attached word document. The form must be maintained in MS Word format.

Application Forms (Print and Submit in Sealed Envelope)

- 1) Entry Form
- 2) Concealed Credits Form. To maintain anonymity, no names of entrants or collaborating parties may appear on any part of the submission, except on the concealed credits form.
- 3) Photography Release Form.

Exhibition / Publicity

All entries will be posted to the DXR'09 web site using the publicity image provided. It is therefore essential that drawings and photographs not be restricted against publication. It is the entrant's responsibility to clear all drawings and photographs for release by Design Expo Raleigh, which will assume no responsibility for copyrights or photographic fees. The photographs for each award winning entry will be used for unrestricted newspaper, magazine, and website publicity. Credit must be given to the photographer by the entrant. Original drawings or models are not to be submitted and the Design Expo Raleigh will accept no liability for them.

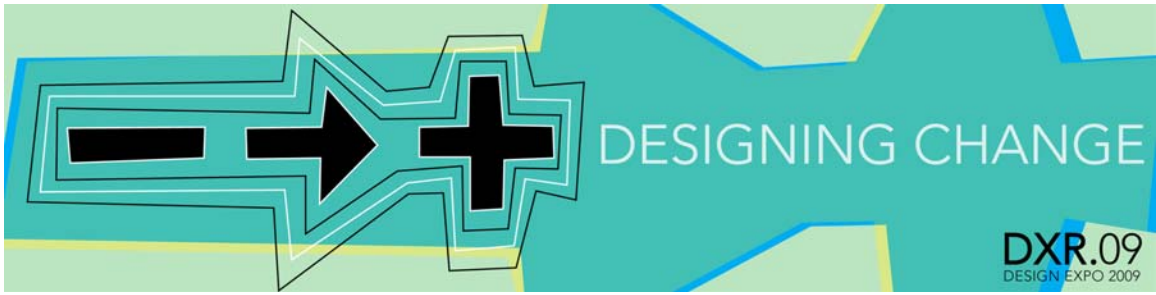
